Minutes of Meeting Dated 02/12/2015

President, Dy GS and AGS Mr. A R Jangid visited Corporate office and met with different available layers of Management & Unions/Associations.

Meeting with President (NFTE):- Our delegation made him aware about Name of circles which have not been answered to CO regarding Vacancy position of JTO internal quota. He assured to intervene personally & updated of insertion this agenda in their upcoming meeting with Dir(HR) on 11/12/2015.

Meeting with GM(Estt.): -President explained the curiosity of our members for JTO LICE which is unnecessarily being delayed by seeking vacancy position. He presented the copy of Last guidelines provided by Estb section in December 2012 where All circles were instructed to calculate the vacancy itself and notify the exam. He focused that in our last meeting with Director(HR) it was committed to initiate both process parallel Regularization of Officiating JTOs & TTA to JTO LICE. Smt. Madhu Arora stated that concerned SDE & DGM are continuously perusing remaining 11 circles Telephonically/Messaging daily and expecting the details within one or two week. She cleared that after collecting all circles vacancy position they will immediately put for its approval and Notifications. She cleared that probably individual circle will be directed to notify the exam and it should be conducted by out side Agency online, same Day on PAN India bases. President also demanded to assure Question paper must be of Diploma level so that objective of this lengthy task may be fulfilled. She assured to expedite the process.

Meeting with GM(Restrg) :- Our delegation met with with GM(Restrg) Mr M P Gupta and tried to know the status of Designation change issue. He told that they will be able to clear in next week after consultation with Dir(HR).

Meeting with Sr GM(SR):- A formal meeting made with Sr GM(SR) Sh Shameem Akhtar . He cleared that they have to make a revise note for updating the designation of OAs.

Meeting with GS(SNEA):- Our delegation urged to intervene the JTO LICE process and provided list of remaining circles which vacancy position is not received. He assured to do needful.

Meeting with Dy GS(AIGETOA):- In this meeting they cleared that they want our support for Superannuation issue and cleared that their major objective reg new JTO RR is oppose of scale degradation from EIA to E1.

Our delegation tried to met Director(HR), GM(Rectt),GS(BSNLEU) & GS(AIBSNLEA) but couldn't due to their busy Schedule/Absence.
