Kindly refer to this office letter no. 26-07/2011-T&C-CM dated 10.07.2014, 16.07.2014, letter of even no. dated 21.01.2015, 29.05.2015 and orders/clarifications issued from time to time with regard to tariff under prepaid mobile services. Now It has been decided by competent authority to rationalize the base tariff of 'Per Second Plan', 'Per Minute Plan', 'Pyari Jodi Plan' under prepaid mobile services as under:-
